

#### HISTORY OF AADFI

In 1969 in Freetown, Republic of Sierra Leone, was held the first meeting of Directors of African National Development Banks. It allowed the banks CEOs to examine ways to strengthen cooperation between development finance institutions in Africa. From 4 to 7 March 1975, another meeting resulted in the establishment of the Association of African Development Finance Institutions (AADFI) under the auspices of the African Development Bank (AfDB). The AADFI currently brings together 80 banks and financial institutions involved in African development financing activities. the Headquarters of the Association is located in Abidjan, Republic of Côte d'Ivoire.

#### **OBJECTIVES**



- Stimulate finance cooperation for economic and social development in Africa.
- Establish among members systematic exchange of technical information.
- Encourage the implementation of studies on issues of common interest.
- Accelerate the process of economic integration in Africa.

#### **ACTIVITIES**

The main activities of the AADFI are information and training of African professionals in banking and financial techniques.

#### **COOPERATION**

The AADFI is represented by a network of financial and banking institutions. It maintains close cooperation with several international organizations and institutions including the African Development Bank (AfDB), The Islamic Development Bank, Golda

Meir Mount Carmel Training Center (MCITC) in Israel, Giordano Dell'Amore Foundation in Italy, the United Nations Industrial Development Organization (UNIDO), the United Nations Economic Commission for Africa (ECA), the African Union (AU) and the World Bank Group. In August 1975, AADFI obtained an observer status with the World Bank. The AADFI is a member of the World Federation of Development Financing Institutions (FEMIDE), which brings together AADFI and its counterparts including the Association of Development Financing Institutions in Asia and Pacific (ADFIAP), the Association Development Finance of Institutions in Latin America (ALIDE), the Association of Development Finance Institutions in members countries of the Islamic Development Bank (ADFIMI).

#### **ORGANISATION**



The administrative organs of the AADFI are: The General Assembly, the Executive Committee and the General Secretariat.

#### The General Assembly

It is the body that sets policy, regulations and procedures necessary for the proper functioning of the Association. It holds regular meeting once a year. It may also hold extraordinary meeting in accordance with the regulations of the Association.

#### The Executive Committee

It directs the activities of the Association and supervises the General Secretariat. It comprises the Bureau; (Chairman and two Vice-Chairmen), five members representing the five sub- regions, as defined by the CEA or as may be determined from time to time by the General Assembly and a member elected by the Special and Honorary members.

#### The General Secretariat

The General Secretariat is the body responsible for the implementation and management of the daily activities of the Association.

#### IMPORTANT ACHIEVEMENTS OF AADFI

# 1. Prudential Standards, Guidelines & Rating System (PSGRS) for African DFIs

The PSGRS is one of the flagship achievements developed and

adopted in 2008 to strengthen African DFIs to operate with best practices. The process of its development was supported by AfDB and FIRST. The mechanism also serves as transformation tool for DFIs and it is currently used to peer review and rate African DFIs. The PSGRS assesses DFIs in three key areas of Prudential Standards namely: Governance, Financial and Operations.



# 2. Acquisition of a Headquarters for the AADFI

The Association with assistance of the AfDB acquired a



Headquarters for the AADFI and signed a Headquarters Agreement with the Government of Côte d'Ivoire in 1998. Realizing the importance of a good Headquarters, the Association

at its OGA held in Senegal in 2009 decided to renovate the Headquarters complex in Abidjan, Cote d'Ivoire. Accordingly, member-institutions made contributions for the renovation of the buildings and acquisition of additional land for extension.

#### 3. Building the Capacity of DFIs and Stakeholders

AADFI has played active role in building the capacity of professionals in African DFIs and other stakeholders through innovative capacity-building activities. The AADFI's recent performance indicator showed that between 2009 and 2014 over 2,558 professionals were trained, an average of 426 trained annually for the period.

#### 4. Personalities and Development Partners



#### 4. Institutions and Establishments



• African Development Bank (AfDB) provided human, material and financial support for the establishment of AADFI; hosted the AADFI Secretariat at AfDB Headquarters and pro-

tariat at AfDB Headquarters and provided human, material and financial support until autonomy in 1994. It provided grants to purchase Association's own Headquarters building; Provides logistic support for the organization of the Association's Annual General Assembly Meetings as well as Technical support for workshops and seminars.



• Banque Nationale d'Investissement (BNI), Cote d'Ivoire rehabilitated the Headquarters Building single-handed for the Association when the Association's building was first in distress and granted the Association a loan to purchase the Headquarters extension land.



• The Industrial Development Corporation (IDC) of South Africa, provided a grant to recruit a Training Officer for the Association and paid the officer's salary and emoluments for

a period of six years. It provides Technical support and grants to AADFI for the organization of workshops and seminars.
