## TALKING POINTS FOR HON. MITHIKA LINTURI, CABINET SECRETARY FOR AGRICULTURE AND LIVESTOCK DEVELOPMENT KENYA DURING THE AADFI CONSULTATIVE LUNCHEON AND AWARDS ON 28TH MAY 2024 IN NAIROBI COUNTY
